

STRUCTURAL COMPONENTS

MODULAR FOAM PADDED COLLECTION. OUTDOOR VERSION: MADE OF OKUME' SOLID WOOD AND PADDED WITH DRYFEEL OUTDOOR FOAM. INDOOR VERSION: MADE OF FIR WOOD AND PADDED WITH STANDARD INDOOR FOAM.

SEATS: OKUME' (OUTDOOR)/ FIR(INDOOR) WOOD FRAME, QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + HEATBOUND POLYESTER FIBER COMBINED WITH POLYESTER MESH, WITH TRANSPIRING POLYESTER MESH. REMOVABLE CUSHION COVER. **CUSHION A1:** QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + HEATBOUND POLYESTER FIBER COMBINED WITH POLYESTER MESH, WITH TRANSPIRING POLYESTER MESH. CHARACTERISTICS OF THE COVERS ARE DESCRIBED IN THE VARASCHIN FOLDER "FABRICS".

OUFIT COVER: THE COVERS OF OUR BELT, BENTO, BARCODE, BIG IN&OUT COLLECTIONS ARE SUITABLE FOR THE PROTECTION AGAINST THE ATMOSPHERIC AGENTS. THEY ARE CUSTOM-MADE PIECES ACCORDING TO THE SOFA COMPOSITION CHOSEN BY THE CUSTOMER. SOFA AND COVERING ARE PRODUCED AT THE SAME TIME AND ARE COMPOSED 100% OF POLYESTER FABRICS, WITH A DENSITY OF 180 GRAM PER SQUARE METER. THE POLYESTER FABRIC IS LIGHTGREY AND HAS ONE SIDE OF ACRYLIC RESIN AND TEFLON COATING, WHICH MAKES THE FABRIC WATER- AND OIL PROOF. THESE COVERINGS HAVE BEEN DESIGNED AND CREATED TO RESIST THE DIRECT WATER PASSAGE ACCORDING TO THE TECHNICAL STANDARD UNI EN 20811, THE WATER PERMEABILITY AND THE WATER COLUMN TEST HIGHER THAN 1000 MM.

COMBINATIONS

BENTO ALLOWS YOU TO CREATE MULTIPLE COMBINATIONS THAT CAN BE DEFINED EVEN AT A LATER STAGE AND MODIFIED BY THE CUSTOMER. IT IS, IN FACT, POSSIBLE TO CHANGE THE COMPOSITION ON DIFFERENT OCCASIONS AT YOUR LEASURE. WITH THE SAME THOUGHT IN MIND, THE CUSTOMER CAN ADD MODULES IN A SECOND MOMENT, CLEARLY RESPECTING THE RULES OF THE MODULAR SYSTEM.

SOFAS OF BENTO COLLECTION CAN BE MATCHED BY COMBINING SIDES OF THE SAME LENGTH AND, IN ANY CASE, BY RESPECTING THE SCHEME REPRESENTED IN THE LEFT SIDE OF THE PAGE.

IN MARINE ENVIRONMENTS ARTICLE SHOULD BE WEEKLY WHASED WITH FRESH WATER. WE WOULD ADVISE USING GOLDEN CARE PRODUCTS AS THEY ARE SPECIALLY DESIGNED FOR CLEANING METAL, GLASS AND SYNTHETIC FIBRES.
